With reference to your application made to the NCTE, the University of Kalyani and all other competent authorities regarding introduction of B.Ed. Course at Nathulal Das B.Ed. College, Plot No.368, 369, Vill-Manikpur, P.O. Dafahat- 742224, Tehsil/Taluka – Jagtai – II, Town/City – Aurangabad, Dist. Murshidabad (West Bengal) from the academic session 2014-2015 under the affiliation of University of Kalyani, as well as NCTE recognition order No. ERC/7-148.6.8/NCTE/B.Ed.-Additional Course/2013/15786, dated 18.01.2013, and approval of the State Government vide G.O. No.816(2)-Edn(CS)/4C-36/12, dated 22.10.2013, the Vice Chancellor, University of Kalyani has been pleased to grant affiliation temporarily for one year (for the academic session 2014-2015) to the aforesaid College for introduction of B.Ed. Course subject to fulfillment of the conditions laid down in the inspection report.

Further I am to inform you that:-

- 1. Intake capacity of the College must be restricted to 100 (one hundred) according to the NCTE
- 2. Recommended Course fee of the University is ₹ 50,000,00 (Rupees fifty thousand) only per student per academic session.
- 3. Course fee is inclusive of all charges including registration fee. No separate extra registration fee can be charged from any candidate. Ten percent (10%) of the course fee must be deposited to the University as registration fee.
- 4. In case of admission of candidates who have passed from this University further registration is not required. But for each of them the College will be required to pay 5% of the course fee to the
- 5. 10% of the total seats be kept reserved for poor and deserving candidates and in their cases charge should not exceed the limit of 25% of the total charges.
- 6. Staying in college hostel, if any, is not mandatory for students. Day scholars should also be allowed for admission.
- 7. Admission under management quota be restricted maximum upto 10% of the approved intake capacity.
- 8. Advertisement inviting applications for admission to the course should be published in the leading dailies in case the University is not organizing central counseling before admission.
- 9. Regarding admission and allied matters, the college will approach the Controller of Examinations, University of Kalyani. Admission will have to be made strictly according to the NCTE norms and a complete list of admitted candidates be sent to the Controller of Examinations, University of Kalyani.
